



# CONDITIONS OF USE

## GENERAL:

- The Hanging Rock Recreation Reserve is self funded and unfortunately receives no State or Local Government operational funding, it is therefore necessary to charge entry fees which enable the ongoing operation, care and development of Hanging Rock.
- The Hanging Rock Annual Pass is for PERSONAL USE ONLY, it is not to be used for commercial purposes. Failure to adhere to this condition will result in the cancellation of your Annual Pass.
- The Hanging Rock Annual Pass is not transferable and should only be used by the applicant or persons within the applicant's household.
- Applications for a Hanging Rock Annual Pass will not be considered where conditions of use have previously not been adhered to.
- The Hanging Rock Annual Pass access card remains the property of the Macedon Ranges Shire Council.
- A limit of 1 access card per applicant applies.
- No refunds will be given for the cancellation of a Hanging Rock Annual Pass.
- The Hanging Rock Annual Pass is not valid on major event days.

## ANNUAL PASS TERM & FEES:

- The Hanging Rock Annual Pass is valid for the twelve month period from 1 July 2011 to 30 June 2012.
- The Hanging Rock Annual Pass fee is payable prior to an Annual Pass being issued.
- Should an application for a Hanging Rock Annual Pass be made part way through the year the fee will be charged on a pro-rata basis (see below).
- Should an applicant lose their Hanging Rock Annual Pass access card, a fee of \$12.00 will apply for a replacement access card.

**Hanging Rock Annual Pass Fee:** (If pass is purchased prior to 30 September 2011) **\$55.00**

### Pro-rata Application Fees:

Pass Purchased between 1 October 2011 to 31 December 2011	\$43.00
Pass Purchased between 1 January 2012 to 30 April 2012	\$31.50
Pass Purchased between 1 May 2012 to 30 June 2012**	\$55.00

*\*\*Pass valid for 14 months until 30 June 2013*

**Subsequent Renewal of Annual Passes Fee:** **\$43.00** (if replacement access card not required)  
**\$55.00** (if replacement access card is required)

*\*Please note renewal notices are sent each year to current Annual Pass holders and  
MUST be paid in full prior to 1st August each year.*
