Conditions of Use

General

- The Hanging Rock Recreation Reserve is self-funded and unfortunately receives no State or Local Government operational funding. It is therefore necessary to charge entry fees which enable the ongoing operation, care and development of Hanging Rock.
- The Annual Pass is for personal use only. It is not to be used for commercial purposes. Failure to adhere to this condition will result in the cancellation of your Annual Pass.
- The Annual Pass is not transferable and should only be used by the applicant or persons within the applicant's household.
- Applications will not be considered where conditions of use have previously not been adhered to.
- The access card remains the property of Macedon Ranges Shire Council.
- A limit of 1 access card per applicant applies.
- No refunds will be given for the cancellation of an Annual Pass.
- The Annual Pass is not valid on major event days.

Annual Pass Term and Fees:

- The Annual Pass is valid for the 12 month period from 1 July 2017 to 30 June 2018.
- The Annual Pass fee is payable prior to an Annual Pass being issued.
- Should an application for an Annual Pass be made part way through the year the fee will be charged on a pro-rata basis (see below).
- Should an applicant lose their access card, a fee of \$12 will apply for a replacement access card.

Fees

If the pass is purchased:

 prior to 30 Sept 2017: 	\$68
• between 1 Oct 2017–31 Dec 2017:	\$55
 between 1 Jan 2018–30 Apr 2018: 	\$44.50
• between 1 May 2018–30 June 2018 (valid for 14 months until 30 June 2019):	\$68

Renewal of Annual Pass: \$55 (Renewal notices are sent each year and must be paid in full prior to 1 August each year.)

All prices quoted include GST.

Privacy
